Schedule a **free counseling** appointment with one of our clinicians if you:

- Need assistance working through your thoughts and feelings,
- Are experiencing uncomfortable symptoms,
- Want to find ways to cope, or
- Are affected by your loved one's experience or wish to better understand and support them.

...accepting that things may never be the same, but they can be better than they are now.

Join one of our **support groups** if you:

- Wish to heal with the support of others who have been there
- Want to know others who share your story
- Want to know you are not alone.
